## Contract Terms:

---

From this point on, "Okie Pride Puppies" refers to Amanda and/or Patrick Dickerson and "buyer" refers to \_\_\_\_\_ . "This puppy" refers to the Great Dane puppy whose code is: \_\_\_\_\_. "Transfer Date" refers to \_\_\_\_\_, which is the date wherein possession of this puppy was transferred from Okie Pride Puppies to the buyer.

Okie Pride Puppies certifies that this puppy is healthy, of sound temperament, and free of communicable diseases on the transfer date. However, Okie Pride Puppies does not guarantee the temperament and health of this puppy after the transfer date.

## Payment and Deposit terms:

---

The full listed price of this puppy is due in full before the buyer takes possession of this puppy. A nonrefundable deposit of at least \$500 will hold this puppy until the balance is paid in full and this puppy is at least 8 weeks of age. The deposit amount will be subtracted from the full listing price to be due before the transfer date. Okie Pride Puppies will not release this puppy into the buyer's possession until the full listed price for this puppy is paid.

## Initial Veterinary Checkup

---

Buyer has 4 calendar days from the transfer date to have this puppy examined by a licensed veterinarian. A copy of the veterinary exam must be sent to and confirmed by Okie Pride Puppies within 7 days after the transfer date or the health guarantee of this contract is null and void. If this puppy is found to have a life-threatening illness or congenital defect at the initial veterinarian exam, with verified veterinary records, a refund of the purchase price with the \$500 nonrefundable deposit subtracted, OR replacement puppy will be given from current or future litters. Life threatening illnesses are the only conditions that will entitle the buyer to a refund or replacement puppy after the date of transfer.

Under no circumstances is Okie Pride Puppies responsible for any veterinary costs or expenses after the transfer date.

## Food and Environment:

---

Buyer agrees to socialize their puppy, train this puppy, keeping this puppy indoors in a clean environment, away from extreme heat and cold as often as possible, feed this puppy a high-quality food daily, and provided with clean water daily.

Buyer agrees to only feed a high-quality food with a CALCIUM level at 1.6% or less and a PHOSPHORUS level at 1% or less until this puppy is 2 years of age.

## Registration

---

When choosing a name for this puppy to be listed on the AKC registration paperwork buyer agrees to include "Okie Pride" in this puppy's name. (Remember that the listed name on the AKC paperwork has no bearing on what you call your pet day to day). You will receive registration information after proof of spay/neuter is confirmed by Okie Pride Puppies.

## Spay/Neuter

---

Buyer agrees to not have this puppy spayed or neutered until at least 18 months after the date of birth. Okie Pride Puppies will withhold AKC registration information until verification of the spay/neuter has been completed.

## Health Guarantee

---

This puppy's health is guaranteed against life threatening congenital defects for 24 months. If within 24 months of this puppy's birth date this puppy is diagnosed with a congenital defect that is life threatening, buyer agrees to inform Okie Pride Puppies of the issue within 48 hours of a veterinary diagnosis. Veterinary statements must be provided to and confirmed by Okie Pride Puppies within 7 days of the diagnosis or this guarantee is null and void. Okie Pride Puppies withholds the right to confirm or deny the nature of the diagnosis as grounds for a refund or replacement puppy. Once confirmed that the diagnosis warrants a refund or replacement puppy, possession of this puppy may be relinquished to Okie Pride Puppies and the buyer is entitled to either a refund of the purchase price with the \$500 nonrefundable deposit subtracted, or a replacement puppy of similar value from current or future litters. If buyer chooses to keep this puppy and treat the illness/condition, buyer is NOT entitled to a refund or replacement puppy.

Okie Pride Puppies is under no circumstances to be responsible for any veterinary expenses after the transfer date.

## Vaccines:

---

Okie Pride puppies does not condone the vaccination of this puppy before 16 weeks of age. We have many resources for information on the nature of vaccinations and the dangers associated with annual revaccination and are providing that information to you as part of your welcome home gift. It is highly suggested to avoid all forms of vaccination for your entire family, including your animals.

## Return Policy

---

This contract is nontransferable. If for any reason the buyer is unable to care for this puppy properly, buyer will inform Okie Pride Puppies of all issues and allow Okie Pride Puppies to either resume possession of this puppy or assist in the rehoming of this puppy. Buyer agrees to never surrender this puppy to any kind of shelter or rescue nor to sell or gift this puppy to a new owner without giving the Okie Pride Puppies the first right of refusal.

NO REFUNDS WILL BE GIVEN FOR SURRENDERING YOUR PUPPY.
